S. No.	Points Of Discussion
	The meeting was formally started with the recitation of Holy Quran.
1.	The chairman Standing Committee Mr. Manzar Khursheed Sheikh inaugurated the meeting & thanked all the participants, agenda points of this meeting was taken from the last meeting held on 6 th July 2012.
2.	Presentation was given by Ms. Afsheen Siab Kayani from R&D Department.
3.	After the presentation, Chairman Standing Committee open the house for recommendations
5.	Mr. Najam Rehan shared with the members "Beggars are the main issues of cantonment areas ". He also pointed out that Cantonment hospital is working in a poor condition there are many People who can take up the project. Mr. Najam Rehan pointed out that there are three types of laws working in Rawalpindi i.e TMA, Cantt and Islamabad this issue may be address to avoid complications in future.
6.	Syed Asad Mashadi emphasized that Old Grant and lease matter may be prioritized in the meeting with station commander so that this matter can be solved.
7.	Mr. Abdul Rauf Chuudery suggested that for proper implementation application may be submitted to the ministry of defense.
8.	Mr. Shaikh Hafeez pointed out that there is the problem of double taxation in the professional tax system, this problem creates ambiguity in procedures, it was suggested that single tax collection body may be decided.
9.	It was suggested by members that cantonment should introduce one window operation desk which can facilitate the members in short span of time.
10.	Mr. Rashid Wayn suggested that there may be " KHULI KACHARI" concept introduced by cantonment board where the entire citizen may share their problems with the cantonment officials.
11.	It was proposed that Hospital Road may be converted to one way traffic to avoid blockages.
12	It was highlighted in the meeting that in cantonment areas like Peshawar Road, mall road drinking water is the main issue.
13	It was proposed in the meeting that for fire brigade a separate water connection may be set up in all commercial area Plazas.

14	Corruption is the main issue of the encroachment said by Mr.Saqib
15	Al-Amin Plaza parking was the main issue rose by almost every member.
16	Mr.Jamshed pointed out that in scheme three due to schools traffic issue is rising.
17	Mr.Shakeel highlighted that 52 shops in Gawalmandi area were sealed without proper notices and this practice should not be adopted & notices prior to sealing of premises be given to occupants.
18	Grave yard facility is insufficient in Cant Area.
19	It was suggested in the meeting that plenty of plantation is required for Rawalpindi.
20	It was proposed in the meeting that tax collection teams may be formulated.
21	The meeting was adjourned with the formal vote of thanks .
